1. Acknowledgment of Risk

I understand that motocross and related activities conducted at Central Cycle Club are inherently dangerous and involve risks including, but not limited to:

- Bodily injury or death
- Being struck by motorcycles or debris
- Falls or collisions
- Unsafe terrain or track conditions
- Weather-related hazards

I voluntarily assume all risks associated with entering restricted areas, trackside zones, pit areas, and any other location on Central Cycle Club property.

2. Release of Liability

In consideration of being granted media access, I hereby release, waive, discharge, and hold harmless Central Cycle Club, its officers, members, volunteers, staff, sponsors, and property owners from any and all liability, claims, demands, actions, or causes of action arising out of:

- Personal injury or death
- Property damage or equipment loss

- Accidents or incidents occurring on the premises
- Any activity associated with the event

This release applies whether caused by negligence or otherwise, to the fullest extent permitted by law.

3. Media Responsibility & Indemnification

I acknowledge and agree that:

- I am solely responsible for the storage, protection, editing, distribution, licensing, and sale of any media I capture on Central Cycle Club property.
 - Central Cycle Club is not responsible for disputes related to image use, copyright claims, privacy claims, rider likeness rights, or financial transactions between myself and third parties.
 - I will indemnify and hold harmless Central Cycle Club from any claims, damages, legal fees, or liabilities arising from the creation, publication, sale, or distribution of my media content.

4. Rider Likeness & Commercial Use

I understand that I am responsible for obtaining any necessary permissions from riders or guardians for commercial use of their image.

Central Cycle Club does not grant permission on behalf of riders and does not mediate disputes related to media sales or image rights.

5. Safety Compliance

I agree to:

- Remain in designated media areas and never cross the track during active racing unless directed by event officials. Media are prohibited from standing in or on the edge of the race track or otherwise interfering with the race and must maintain a safe distance from the designated edge of the track surface at all times.
- Follow all instructions from race officials and staff
- Have required media credential visible at all times
- Avoid interfering with race operations including but not limited to signaling riders, cheering or providing mechanical assistance
- Dress Appropriately: T-shirts and polo shirts, shorts and pants, and close-toed shoes (no sandals, clogs, etc) must be worn at all times; tank tops, sleeveless shirts, crop tops, beach wear, tight, revealing, or otherwise inappropriate clothing, as well as apparel with inappropriate or indecent logos/markings is prohibited

Failure to comply may result in immediate removal from the property and revocation of current and future media access.

6. No Employment Relationship

I understand that media access does not create an employment, partnership, or agency relationship with Central Cycle Club.

I am acting independently and at my own risk.

7. Certificate of Insurance Requirement

As a condition of receiving media credentials, all applicants must provide a valid Certificate of Insurance (COI) prior to the event date.

The certificate must:

- Show proof of Commercial General Liability insurance
- Provide minimum coverage limits of **\$1,000,000 per occurrence**
- Be valid for the date of the event

Under Additional Insured, it should read:

“Central Cycle Club, Inc., its officers, members, volunteers, and property owners.”

Media credentials will not be issued without receipt and approval of a valid Certificate of Insurance. No exceptions will be made. Failure to provide a valid Certificate of Insurance prior to the event will result in denial of media access.

Central Cycle Club reserves the right to verify coverage with the issuing insurance provider and to reject any certificate that does not meet these requirements.

8. Agreement & Signature

By signing below, I certify that:

- I am at least 18 years of age
- I have read and fully understand this agreement
- I voluntarily agree to all terms
- I understand I am giving up substantial legal rights

This agreement shall be governed by the laws of the State of Connecticut. If any portion of this agreement is found unenforceable, the remaining provisions shall remain in full force and effect.
